It is important to agree the standards of ethical behavior for all of the participant in this published journal includes the author, the journal editor, the peer review, and also the publisher. Department of Aquaculture, University of Muhammadiyah Malang as the publisher of this Journal, takes its duties of guardianship over all stages of publishing extremely seriously and we recognize our ethical and other responsibilities. We are committed to ensuring that advertising, reprint or additional commercial revenue has no impact or influence on editorial decisions. In addition, the Department of Fisheries, University of Muhammadiyah Malang and Editorial Board will assist in communications with other journals and/or publishers where this is useful and necessary.

For Editors

- 1. The editor decide which submitted articles should be published in IJOTA (Indonesian Journal of Tropical Aquatic).
- 2. An editor should evaluate manuscripts for their intellectual content without regard to race, gender, sexual orientation, religious belief, ethnic origin, citizenship, or political philosophy of the authors.
- 3. The editor and any editorial staff must not disclose any information about a submitted manuscript to anyone other than the corresponding author, reviewers, potential reviewers, other editorial advisers, and the publisher, as appropriate.
- 4. An editor has to evaluate the manuscript objectively for publication, judging each on its quality without looking to nationality, ethnicity, political beliefs, race, religion, gender, seniority, or institutional affiliation of the authors. He/she should decline his/her assignment when there is a potential for conflict of interest.
- 5. Editors should recuse themselves (i.e., should ask a co-editor, associate editor or another member of the editorial board instead to review and consider) from considering manuscripts in which they have conflicts of interest resulting from competitive, collaborative, or other relationships or connections with any of the authors, companies, or (possibly) institutions connected to the papers.
- 6. Editors should require all contributors to disclose relevant competing interests and publish corrections if competing interests are revealed after publication.
- 7. An editor should take reasonably responsive measures when ethical complaints have been presented concerning a submitted manuscript or published paper, in conjunction with the publisher (or society).

For Reviewers

- 1. Peer review assists the editor in making editorial decisions and through the editorial communications with the author may also assist the author in improving the paper.
- 2. Any selected referee who feels unqualified to review the research reported in a manuscript or knows that its prompt review will be impossible should notify the editor and excuse himself from the review process.
- 3. Any manuscripts received for review must be treated as confidential documents. They must not be shown to or discussed with others except as authorized by the editor.

For Authors

- 1. Authors of reports of original research should present an accurate account of the work performed as well as an objective discussion of its significance.
- Authors may be asked to provide the raw data in connection with a paper for editorial review, and should be prepared to provide public access such as data, if practicable, and should, in any event, be prepared to retain such data for a reasonable time after publication.
- The authors should ensure that they have written entirely original works, and if the authors have used the work and/or words of others that has been appropriately cited or quoted.
- 4. An author should not, in general, publish manuscripts describing essentially the same research in more than one journal or primary publication.
- 5. Authors should cite publications that have been influential in determining the nature of the reported work.
- 6. Authorship should be limited to those who have made a significant contribution to the conception, design, execution, or interpretation of the reported study.
- 7. All authors should disclose in their manuscript any financial or other substantive conflicts of interest that might influence the results or interpretation of their paper.
- 8. When an author discovers a significant error or inaccuracy in his/her published work, the author should promptly notify the journal editor or publisher and cooperate with the editor to retract or correct the paper.
- 9. If the editor or the publisher find a significant error, the author should retract or correct the paper or provide evidence to the editor of the correctness of the original paper.

AUTHOR GUIDELINES

Manuscript should be uploaded to OJS system and arranged in IJOTA standard format, Title, Authors, Address and Email, Abstract, Keywords, Introduction, Materials and Methods, Result and Discussion, Conclusion, Acknowledgment, and References. Typed at Microsoft Word in the white paper of A4 size, in single column, a spaceline, 12 point Times New Roman font and should be given line numbers. Margins on all four sides are 3 cm. Maximum pages of the manuscript not more than 18 pages.

The manuscript should contain the following section in order:

A. Title

Title consist of no more than 20 words. It should be written clear and concise in describing the contents of the research.

B. The author-name

Manuscript has the main author and co-authors with the full name of the author and coauthors (no abbreviation), includes email addresses.

C. Abstract

Give a brief introduction to the research. Identify the scientific names of plants, other organisms, and chemicals. Abstract should not be more than 250 characters that have no reference and accompanied keywords. The abstract must be integrated and independent which consists of introduction, purpose, methods, results, conclusion, and suggestion.

Key words: The keywords and phrases following the Abstract should be alphabetically arranged and should reflect the contents of the paper. Manuscript should have keywords 3-5 words or phrases.

D. Introduction

Presents brief and clear information concerning the background, aim and purpose of the research.

E. Methods

It should mention the time and place of the research. All materials and methods used such as chemicals for analysis, treatment and experimental design, must be explained briefly but clearly.

F. Results and Discussion

Result and discussion must be written in the same part. They should be presented continuously start from the main result to the supporting results and equipped with a discussion. Unit of measurement used should follow the prevailing international system. All figures and tables in manuscript should be original, active and able to be edited by editor.

G. Conclusion

Conclusion should be explained clearly based on the results of the research described in the manuscript.

H. Acknowledgement

Mention the grant source or/and the person to whom the grant was given. Name the person to help your research or compile the manuscript.

I. References

The author-year notation system is required and completed. All reference mentioned should be written down in reference using American Psychological Association (APA) style. The most of references are primary ones (last five years).

Unpublished data and personal communication should not be cited as literature citations, but given in the text in parentheses. "In Press" articles that have been accepted for publication may be cited in references. Include in the citation the journal in which the "in press" article will appear and the publication date, if a date is available. The Author must use a reference manager, such as Mendeley, Zotero, or Endnote. This manuscript without using a reference manager will not be accepted until revised with reference manager.

Submission Preparation Checklist
